Listening to the light-hearted bantering exchange between mother and child and watching the attention and care the parents showered on the infant made me very aware of how deeply the baby was cared for and how dependent it was on that care from its parents. Every year we rely on charitable giving and income from that charitable giving for around 95% of our operating budget. Kurn Hattin does <u>not</u> derive substantial funding from annual tuition like other independent schools; most of our families are not able to pay any tuition in order for their children to attend. While we do appreciate our reserved funds (endowment), which are composed of charitable contributions from throughout our history, they do not provide nearly enough income to fund annual operations. Therefore, we must rely on the love and care of those who have the ability and desire to cherish us, just like a newborn baby relies on its parents for sustenance. Your gift makes our work possible!

I want to express our deep, deep gratitude for each one of you who contributes to the fulfillment of our mission. Because of you, each of you, we continue to transform children's lives-one gift at a time and one child at a time. Because of you a child feels safe at night-every night-in our well-appointed cottages. Because of you a child enjoys consistent (three meals a day and snacks), fresh, healthy, and delicious food (much of it from our own fields)-perhaps for the first time in her or his life. Because of you a child can learn in the classroom at a rate that meets his or her individual needs from teachers who truly care about the child. Because of you a child can play on the playground or on an organized team, enjoying the thrill of play as a child should. #### **ANNUAL REPORT** FROM THE FINANCIAL MANAGER

In preparing this report and reviewing the numbers for the table and graph on the next page, one cannot help but appreciate the history of donor support for Kurn Hattin that goes back to 1894. Unlike other private residential schools, Kurn Hattin is not tuition driven. Kurn Hattin is mission driven, with the primary goal of providing a quality home and education to children in need, regardless of the family's ability to contribute towards the program. This would not be possible without the generous donor support received over the years. As the chart on the opposite page indicates, 93% of the funding support for the residential and educational programs is through charitable sources of revenue. The support from annual giving, trusts, bequests and the endowment are all important elements of this funding. Thanks to all of you for your support of Kurn Hattin. We look forward to future generations of donors to sustain Kurn Hattin for years to come.

The fiscal year ending June 30, 2017 was successful with respect to the operations of Kurn Hattin. Collectively, budget managers underspent the budget by \$272,000, or 5%. Overall expenses were \$202,000, or 4%, below Fiscal 2016, Capital expenditures in Fiscal 2016 totaled \$131,480 which included replacing some of our aging vehicles and equipment, replacing furnaces in the Hubbard and Turrell cottages, and repairing the roof on Hubbard. Major roof repair is scheduled for the Mayo school building beginning in the fall of 2017.

It was also a positive year for the endowment, posting a 12.3% investment return for the year, compared to a return of -5.5% in Fiscal 2016. Kurn Hattin's Investment Committee is comprised of board members, staff and three outside investment professionals, who along with our investment advisor Prime Buchholz meet at least quarterly to review investment performance. This volunteer committee works hard to make sure that Kurn Hattin's endowment is in the best position to achieve growth and to support Kurn Hattin's operations. Building the endowment through positive investment performance and new gifts is an ongoing priority. As of June 30, 2016, the endowment value, net of allocations to support the operating budget, stands at \$45.1 million.
